

# Montana Contractors' Association Concrete Division Scholarship

## *2012-2013 SCHOLARSHIP*

### **SCHOLARSHIP**

The scholarship will be awarded by the MCA Concrete Division Committee. The scholarships will be awarded to applicants entering vocational educational training or to applicants entering a 4-year college or university. The amount of the award will be \$500.

### **PURPOSE**

The purpose is to provide assistance to aid in the payment of tuition, books and fees for any qualified dependents of employees or employees of members of the Montana Contractors' Association Concrete Division. Scholarship applicants must meet all of the following criteria:

- A. Maintained a cumulative grade point average from high school of 2.50 or better.
- B. Received a written acceptance from the college, university or other educational institution they desire to attend.
- C. Be graduating from a high school in Montana.
- D. Be a dependent of a member of the MCACD or a dependent of an employee of a member of MCACD who shall have been employed by the member company for at least six months prior to submitting the application. The employee's supervisor must give written notice to be included with application.

The Scholarship Committee will verify the employee's status immediately prior to the awarding of the scholarship to determine if there has been any change to the employee's status between the date of the application and the date of the award.

- E. Complete and submit the scholarship application by **May 18, 2012**.
- F. Be a student accepted in a post-secondary education curriculum.

### **SCOPE**

The scope of the scholarship program is designed to include employee's children graduating from high school, returning from military service or those enrolling in a trade school/vocational educational training program, or 4-year college or university. Students currently attending a 4-year college or university are also eligible at the end of their freshman year. Scholarships are awarded on a one-year basis or a shorter time if that

is the extent of the course. Award for the scholarship will be \$500.

### **OPERATION**

A. Applications from interested individuals will be mailed to the Scholarship Committee as outlined in item D under "Purpose." The Committee will meet to consider applications for full year aid no later than three weeks after May 18, 2012.

B. Selection criteria for scholarship recipients will be based on the following guidelines:

1. Scholastic record and ability.
2. Outside school activities, such as athletics, drama, speech, work experience, etc.
3. Content and appearance of application.

C. At the conclusion of the selection process, all applicants will be contacted; thanking them for their interest in the program and the persons who have been awarded the scholarships will be so informed.

D. No later than two weeks prior to the start of the school year, the Scholarship Fund Committee will mail a check to the recipients designated school for payment of tuition, books and fees for that school term. Scholarship amount will be \$500, \$250 will be available the first semester and \$250 will be available the second semester. (See STUDENT REQUIREMENTS below).

E. Holders of a scholarship from the MCA Concrete Division may accept scholarships from other sources.

F. Should a student fail to qualify for a second term during that year, the remaining funds allocated for his/her use will be returned to the MCA Concrete Division.

G. The fact that one child of an employee has won a scholarship and is attending college will not prevent another child of the employee from receiving a scholarship.

H. Neither the member company nor the MCACD assumes any responsibility for the conduct, personal affairs or debts of scholarship winners or candidates for scholarships, and shall not be liable therefore in any manner.

**STUDENT REQUIREMENTS**

A. No less than the acceptable minimum credits for regular full-time students enrolled in a college or university must be carried (as a full time student, to graduate in four years). The registrar's office will be instructed by the scholarship fund to verify that the student is registered as a full time student prior to releasing scholarship funds to the student's account. Students seeking scholarships for non-college type courses that are of shorter duration, such as diesel mechanics, truck drivers, vocational technical schools or of that type, must clearly state that fact in their application.

B. A minimum cumulative grade point average of 2.5 must be maintained. The scholarship fund will upon remitting the second payment for the year, require the registrar's office verify that this grade point average was attained for the previous semester or term, prior to the release of funds.

C. Individuals may be eliminated from the scholarship program if they are placed on academic or social probation any time for any reason during the school year.

D. The recipient who leaves school for any reason without the approval of the Scholarship Committee, or whose scholastic work falls below the minimum requirements for their degree shall forthwith be dropped from the program.
