Scholarship Application Form *School Year 2012-2013*

The applicant must be a dependent of a member of the Montana Contractors' Association or a dependent of an employee of a member of the Montana Contractors' Association. Students must show enrollment in a post-secondary education curriculum.

Scholarships will be awarded in consideration of scholastic record and ability, outside school activities, record of self-help and on the content and appearance of the application. The scholarship may be used for any field of study including vocational education. Reapplications for subsequent years will be accepted if student has not gone immediately to post-secondary education after graduation from high school.

The school selected must be a regionally/nationally accredited public or private Montana College, University, or College of Technology.
