MCA New Business

- 1. MDT's Design Software: Cale and Jake held brief conversations. Apex Software used for take offs. Designers started using shapes and trapezoids. Unable to extract. Patrick (MDT) discussed that some projects being worked on now are 2-3 years old, using Geopack. Not a lot of success with this process. Civil 3D and Autodesk being researched to pull cross section lines. Will work with contractor on a case-by-case basis. Brandon: Will be providing different files types for delivery. XML files will be provided. Cross-section data is needed during estimating phase. Patrick Lane always ready to help with IT issues. Joe will send out information to group.
- 2. Subcontracts: Cale discussed EPM advising a subcontract is needed for Superior Traffic Services. STS is delivering to the job, and providing some training to on site flaggers for operation and rest is remote, not on job.

Kathy: This is site work and this does involve a subcontract. In this case, a subcontract is needed.

Cale: Language on this job is not different than any other job. Maintaining is done off site. How is this different than renting equipment and it being delivered?

Guy: Some companies won't complete the subcontract as the paperwork takes too much time, and prices increase.

Hal: Then they have to submit certified payroll for David Bacon Wages for 1 day. Jake Goettle: Now that they understand how difficult this is... lets research.

MDT New Business

 Customer Service Survey: Jake Goettle discussed customer service survey to send out to members. Draft questions in progress, sitting at approx. 20 questions. Prefer we wait? Guy advised to send survey to David to include in E-brief. Pat requested that comments be allowed in survey.

Old Business

- Federal Highway Wage Decision Updated: Kathy: Struggling with US DOL to update Highway Wage rates. DOL no longer allowing zone pay. 10-15 states still include zone pay. All states working on removing zone pay. State divided up into metro and rural areas, which allows for different rates based on areas. Cale: MCA needs to have discussion on how to move forward. If turned over to DOL for survey, they are 3-9 years out. Cale, Guy, and Hal will reach out to David to discuss. Jodie Tooley is interested in being involved in this discussion. MCA needs to discuss and decide if they want to be involved in the process.
- 2. MDT Claims Process: Jake: Spec change turn-around time, concerns addressed. Partnering is new and joining with claims process is new also. Future changes are always open.
- Partnering: Jake: Couple of positions approved through the legislature, effective July 1. Developed position description and job profile to post as soon as possible. Working on webpage with resources and having folks being facilitators. Jake: Quad State AGC Meeting: Partnering Successes, and how partnering help with a specific project would be a good agenda item.
- 4. MCA-MDT Environmental Task Force Meeting: Work hasn't been implemented. Specific BMP provision on contracts with endangered species impact. See how the summer goes, and reconvene in the fall.
